Something Positive from a Tragedy

The shootings at Virginia Tech in April were covered by every news media outlet, and while the details of that tragedy are being discovered, there is one happier story that has surfaced. Kevin Sterne, the student engineer at the campus radio station, WUVT, was wounded during the shooting. He was able to use an electrical cord as a tourniquet to stop the bleeding from his leg, which saved his life. He underwent surgery and is currently recovering in the hospital, but he's doing well. Images of Sterne being carried away by four men in informs were part of the new coverage.

Attention from the event created an outpouring of interest to provide support for the victims. In Sterne's case, his dedication to radio caught the attention of many broadcasters. Very soon after the shootings, the SBE contacted the campus radio station to determine the assistance that could be provided to Sterne. The response was that donations and well wishes could be made to the station in Sterne's name. But there's more to the story.

It turns out that Sterne's five-year pet project has been to relocate the station's transmitter. The current transmitter location is in an elevator penthouse on top of a dorm building. The transmitter room does not have air conditioning. In January, the station had some equipment trouble and was operating at about half power through April.

As the SBE and then Clear Channel inquired into the situation, more information came to light, including the school's and the station's plan to relocate the transmitter facility.

The station was able to repair its transmitter and return to full power, and Clear Channel has loaned the station a 3.5kW transmitter to use a back-up for the time being.

Some plans had already been put together to relocate the transmitter to a tower on nearby Price Mountain. The station has been raising money to fund this project. The land on Price Mountain is owned by the school, and the tower is owned by Cumulus.

Now the SBE, Clear Channel, Cumulus and other companies are working together to help the station obtain the authorization needed to relocate the transmitter. Some companies are also preparing to donate equipment if it is needed. In addition, financial donations to the station are being accepted. Donations should be noted as being for "Kevin" or "transmitter." Mail donations and items to:

New Specialist Certification

SBE to Offer New Specialist Certification The National Certification Committee of the SBE has announced its next specialist certification: Digital Radio Broadcast (DRB). This specialist certification will qualify an individual's knowledge of digital radio broadcasting including audio processing, studio-to-transmitter links and transmission of multi-channel digital program streams. The official roll-out of this specialist certification will be during the SBE National Meeting, held in conjunction with SBE Chapter 20's, Pittsburgh Regional Convention, October 10-11, 2007, in Monroeville, PA.

The specialist will include knowledge of importers, exporters, the various methods of combining analog and digital transmitters to antenna systems, delivery of digital audio signals and data to transmitter sites, transmitter emission mask measurements, AM and FM FCC rules, monitoring of digital signals and bandwidth requirements for AM antenna systems.

DRB specialist applicants must currently hold SBE certification at the Broadcast Engineer, Senior Broadcast Engineer, or Professional Broadcast Engineer certification level. The exam will consist of 50 multiple-choice questions and one essay question. Following the roll-out of the specialist certification, the SBE will release an update to its CertPreview software of practice tests. NFL loosens sideline limits on affiliates TV cameras

The NFL has reversed course on its decision to significantly restrict TV cameras on sidelines, an initiative that last season sparked a firestorm of criticism and even threats of lawsuits from the lobby for network affiliate stations.

The league's broadcast committee told owners last week at their annual meeting that up to 10 affiliate TV cameras are now allowed to film game footage from the sidelines. However, to make room for the cameras, there may be restrictions on the number of still photographers on the field.

When the league announced the new policy last year, banning TV cameras that were not part of the live game coverage, some viewed the move as the sport's latest step to restrict any slice of its content to only paying outlets. The league defended the move, arguing the sidelines were dangerous places because of camera clutter, a position with which Banner agreed.

That position did not assuage the National Association of Broadcasters, which represents network affiliate stations. The group last year sent a protest letter to the league, suggesting the policy could violate open-access rules in government-funded stadiums.

Wharton said he was surprised the NFL maintained there was not a total camera ban. Instead, the league last season allowed up to two affiliate cameras per team, so four a game, said NFL spokesman Greg Aiello. Those cameras functioned in a pool system. Previously, there had been no limits.

The new policy increases from two to five the number of affiliate cameras allowed per club. If a visiting team does not bring five affiliates, the home club can make up the difference.

Local affiliates have said that the footage they filmed in previous years highly distinguished their evening news reports' sports highlight shows. Last year's restrictions, the stations argued, hurt the telecasts.

Restrictions on still photographers will be no different than those that have been in place, Aiello said, with teams being able to decide which ones get on the field. Others, however, including Banner, indicated the new policy might give clubs more leeway than before. It was not immediately clear what additional steps would be taken to clarify these effects of the new policy.

There was no decision at last week's meetings on possible further restrictions in another media area. The NFL is considering limiting Internet dissemination of weekly coaches' press conferences and player practice interviews to only approved outlets.

As the article in the previous page indicates, the NFL has favorably revised its sideline policy broadening access to game coverage by local television stations. Team owners agreed to change a 2006 rule banning local station video cameras from the sidelines during games. The new rules will allow up to 10 video crews, **five from the local market** of each competing team, to cover games from the field. Participating stations would be expected to provide pool coverage and those details would be worked out between teams and local stations that cover them.

With this new policy, we will follow the same guide line in frequency coordination. All local TV station will only have one frequency allowed during the game.
